Therefore, the Committee would like to review the program again in October, 2022.

The CAC Committee also indicated they would like Captain Carlos Espinosa to review some investigation cases that were of high concern to the public. This should be scheduled once the "mall shooting" investigation has been completed.

7. HOUSEKEEPING and OTHER BUSINESS:


Mr. Marcus Johnson is a potential candidate for the open District 5 representative.
