3. OPENING:

Mr. Allie Braswell, Jr. opened the meeting at 6:07PM.

4. APPROVAL OF MINUTES:

A motion was made by Ms. Patricia Rumph and seconded by Mr. Kevin Sutton for the approval of the September 8, 2022 meeting minutes.

5. HOUSEKEEPING AND OLD BUSINESS:

Ms. Morfa and Mr. Kidwell CAC extensions approved. CAC meetings scheduled for October and November 2022 were cancelled due to the weather.

Captain Piwowski discussed CAC 2023 extensions and submissions. Also mentioned in this discussion was Commissioner Siplin has asked to have Mr. Kilgore stay on the board, until Commissioner Michael Scott can name a replacement. Commissioner Moore's replacement is Mr. Warren Lewis. Captain Piwowski and Mr. Braswell thanked Mrs. Rumph for her dedication and commitment to this board. The board is still awaiting a vacancy from Commissioner Bonilla. CAC members discussed the lengthy application process as a drawback on the finding volunteers to fulfill this role, OCSO will look into the process to see if this could be streamlined.

7. NEW BUSINESS (DISCUSSION):

John Farrell discussed OCSO CFA Assessment. Captain Piwowarski discussed deputy involved shootings and presented the agency's website to display how to navigate through the site to find comprehensive information on deputy involved shootings that is made available to the public.

Ms. Rumph and Mr. Sutton inquired about mental health assistance offered to staff in deputy involved shootings. Discussion was if comfort canines are part of the CISM team response. Captain Piwowarski answered these inquiries and explained the agency's response to deputy involved shootings. Commissioner Scott inquired about Marsy's Law in regards to deputy involved shootings.

Mr. Sutton and Commissioner Scott discussed lengthy wait times on hold for the OCSO non-emergency number. The recording should discuss going on line to the E-Report webpage. A review of the E-Reporting webpage does not bring someone to the reporting site and will be sent to the Webmaster to look into.

Mr. Sutton talked about a previous CAC recommendation (Traffic Citation 2021) about police education video for the public on interaction during a vehicle stop for Mr. Randolph Scott's Tax Collector office. Mr. Sutton stated Mr. Scott agreed but would need a video with cc captioning to play on traffic stops for the Orange County Tax Collector offices. OCSO will inform media relations.


Mr. Braswell informed the Sheriff and the rest of the members that he will be stepping down after the January CAC meeting.
