- #1 **SHERIFF'S CENTRAL COMPLEX - Central Opps (407- 254-7000)**
2500 W. Colonial Drive
Orlando, FL 32804
Take I-4 to SR50 exit and head west. Located at the corner of SR50/W. Colonial Dr. & John Young Pkwy.
 - **Human Resources Division (407-254-7400)**
Use the western entrance of the building (marked Human Resources, Records, etc.) off John Young Pkwy.
 - **Material Control & Supply (407-254-7060)**
Enter from the southeast side of building off John Young Pkwy.
 - **Training Facility (407-254-7270)**
Use the western entrance of the building (marked Human Resources, Records, etc.) off John Young Pkwy.

- #2 **ECS / 911 COMMUNICATIONS CENTER (407- 836-3980)**
6590 Amory Court
Winter Park, FL 32793
Take I-4 to East/West Expressway (408); proceed east to Semoran Blvd (436); go to University Blvd. and turn right; go to Forsyth and turn right; proceed to Amory Court and turn right to location.

- #3 **ORANGE COUNTY COURTHOUSE - COURT SECURITY / JPT / CPT (407-836-0106)**
425 North Orange Avenue, Room 110
Orlando, FL 32801
From I-4 take Exit 41; proceed east on Amelia Street; at Orange and Amelia you will see the parking garage on the right.

- #4 **VALENCIA CRIMINAL JUSTICE ACADEMY (407-582-8200)**
8600 Valencia College Lane
Orlando, FL 32825
Exit Highway 417 at Valencia College Lane and proceed east. Academy is on right.

- #5 **MEDICAL / CENTRA CARE (407-914-2926)**
630 North Bumby Avenue (near E. Colonial Drive / 50)
Orlando, FL 32803
From I-4, head east on East Colonial Drive (Rt. 50) and then south onto Bumby Avenue. The building will be on the right just south of the E. Colonial/ Bumby intersection (southwest corner).

- #6 **DUI FACILITY (407-836-0800)**
2400 West 33rd Street
Orlando, FL 32839
From I-4, head south on John Young Parkway; turn left onto 33rd Street. Make a right onto Vision Blvd. and then make a left into the Orange County Mental Health Unit parking lot. Call for further instructions.

- #7 **EVIDENCE WAREHOUSE (407-254-6620)**
4536 35th Street
Orlando, FL 32811
From I-4, head North on John Young Parkway; turn left onto L.B. McLeod Road. Head west, then make a left onto Maggie Blvd. Head south on Maggie, then make a left onto 35th Street. Warehouse will be on the right.
