3. OPENING:

Mr. Farrell opened the meeting at 6:02 PM.

4. APPROVAL OF MINUTES:

5. HOUSEKEEPING AND OLD BUSINESS:

Brief explanation of status update of CALEA re-accreditation awarded November 2024.

6. PUBLIC COMMENT:

Submitted Emails for Public Comment were given to the CAC

1. School Parking issue – (forwarded to the SRO, Sector Captain, and Traffic Section)

Public Comments – In Person

1. 6 members of the public present

2. 3 members read statements all about the same subject (a Deputy Involved Shooting (DIS) on February 8, 2025). The members wanted questions answered, which is not part of the public comments section, however some questions were on the process and what the procedures of a DIS are.

These were answered

- a. The Investigation is being conducted by FDLE, not the Orange County Sheriff's Office
- b. The BWC was released within the 30 days (released on March 8th 28 days) after the incident as per our agency policy, which was a recommendation by the CAC in 2020.
- c. Once FDLE completes their report, they will forward it to the State Attorney's Office
- d. State Attorney makes decision
- e. After FDLE and SAO complete their investigations, Professional Standards will review all materials to conduct an internal investigation into the matter.

7. NEW BUSINESS (DISCUSSION):

Annual Statistics:

Mr. Farrell explained and reviewed the 2024 annual statistics for our agency. The attendees were shown how to access the reports through our agency's website. All of our policies are available online and could be viewed by the public at any time. Mr. Farrell also discussed our 2024 CALEA Assessment Report, which provides an overview of data to include traffic warnings, citations, use of force, grievances, personal actions etc. All attendees were informed that they can review the reports at their convenience.

CAC board members:

Mr. Farrell also discussed addressing the absence of board members in this meeting and the last CAC meeting in February. This issue will be mentioned to Sheriff Mina. The discussion may lead to a re-evaluation of current board members with constant absenteeism and possibly the replacement of those board members in the near future.
